

SUPER HUGE INTERNATIONAL TOUR

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. HOW TO ENTER

- a. The SUPER HUGE INTERNATIONAL TOUR contest (the "Contest") will begin on April 13, 2009 at 6:00am Pacific Time ("PT") and end on May 1, 2009 at 5:00pm PT (the "Contest Period").

- b. To participate in the Contest, you may enter via the following method:

On-air: Starting on April 13, 2009 each hour between 6:00am and 10:00pm PT Monday – Thursday and 6:00am to 5:00pm PT on Fridays, the on-air personality will announce a song that will be played sometime during that hour (the "cue to call"). After that song begins to be played on-air, caller 10 to complete their call to 702-791-1075 will be qualified to win that week's trip, pending verification of eligibility ("Qualifier"). On Fridays during the 5:00pm PT hour one (1) winner will be selected at random from that week's Qualifiers to win that week's trip for two. At the time of their call, each caller will be required to give his or her first and last name, complete address including zip code, telephone number, and date of birth. In the event that the selected caller is disconnected, the next caller that successfully makes it through on the call in line and complete their call will be considered that qualifier. The cue to call will be given fifteen (15) times per day Mondays through Thursdays and will be given eleven (11) times on Fridays during the Contest Period for a total of 71 Qualifiers each week. Qualifiers will only be eligible for the weekly drawing that they became a Qualifier for.

- c. No limit on times a person can become a Qualifier each week during the Contest Period.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all KXTE listeners who are **21** years of age or older and who reside in Las Vegas metropolitan area including Clark County Nevada. Employees of KXTE (the "Station"), its licensee, its corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in the Las Vegas metropolitan area and the members of their immediate families are ineligible to participate or win.
- b. Only one winner per household is permitted in any Station Contest.

- c. Winners must have a credit card and valid government issued photo identification
- d. The winners of week #1 and #3 must have a valid passport to win.

WEEK #2 TRIP: TRIP FOR TWO (2) TO CHICAGO FOR THE DISTURBED SHOW. THE TRIP INCLUDES ROUNDTRIP COACH AIRFARE FOR TWO (2) FROM LAS VEGAS TO CHICAGO LEAVING LAS VEGAS ON 5/15/2009 AND RETURNING ON 5/17/2009, HOTEL STAY (DOUBLE STANDARD OCCUPANCY) FOR 2 NIGHTS, AND TWO (2) TICKETS FOR THE DISTURBED CONCERT AT THE CHARTER ONE PAVILLION ON 5/16/09. ARV OF THE WEEK #2 TRIP: \$TBD.

WEEK #3 TRIP: TRIP FOR TWO (2) TO LONDON FOR THE KINGS OF LEON SHOW. THE TRIP INCLUDES ROUNDTRIP COACH AIRFARE FOR TWO (2) FROM LAS VEGAS TO LONDON LEAVING LAS VEGAS ON 6/29/2009 AND RETURNING ON 7/1/2009, HOTEL STAY (DOUBLE STANDARD OCCUPANCY) FOR 2 NIGHTS, AND TWO (2) TICKETS TO THE KINGS OF LEON CONCERT AT THE O2 ARENA ON 6/30/09. ARV OF THE WEEK #3 TRIP: \$TBD.

- b. Travel arrangements must be made through Station's agent on a carrier of Station's choice. No prize substitutions, cash equivalent, or transfer of prizes permitted except at the sole discretion of the Station. Prize subject to availability and the Station reserves the right, at their sole discretion, to award a prize of greater or equal value if the advertised prize is unavailable. If a winner cannot travel on dates specified by Station, that winner may be disqualified and no alternate winner will be drawn. All other costs not specifically stated herein, including, but not limited to, taxes, meals, tips and ground transportation, are the responsibility of each winner. Taxes are solely the responsibility of the winners. Each winner and his or her travel companion must travel on the same itinerary and are responsible for obtaining all required travel documents (including passports for the trip to London and Vancouver). In addition, the travel

companion of each winner must be 21 years of age or older. Each winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during their stay. Each winner and his or her travel companion are responsible for obtaining travel insurance (and all other forms of insurance) where applicable, at their option, and hereby acknowledge that the Station has not and will not obtain or provide travel insurance or any other form of insurance. Each winner his or her travel companion must sign a Publicity, Liability Waiver and Travel Release form prior to traveling. If a selected event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, or for any reason beyond the control of the Station, the Station's sole responsibility to a Winner will be to award the remaining available portion of the prize and no substitution will be provided for unawarded portion of prize. Tickets are subject to terms and conditions as specified by issuer. Seat locations (when applicable) are to be determined by the Station. The Station reserves the right remove or to deny entry to a winner and/or guest if he/she engages in a disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the concert or festival.

- c. All prizes or prize certificates may be picked up at the office of the Station at the address below. The winner will forfeit any prize or prize certificate not claimed within fifteen (15) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize or prize certificate.
- d. There is no substitution, transfer, or cash equivalent for prizes, except that the Station may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Contest are final.
- b. Seventy-one (71) Qualifiers will be selected as described in Section 1 of these Official Contest Rules.
- c. On Friday April 17, 2009 during the 5:00pm PT hour one (1) winner will be selected at random from all the Qualifiers received during the week 4/13/2008-4/17/2008 to win Week #1 Trip.

- d. On Friday April 24, 2009 during the 5:00pm PT hour one (1) winner will be selected at random from all the Qualifiers received during the week 4/20/2009-4/24/2008 to win Week #2 Trip.
- e. On Friday May 1, 2009 during the 5:00pm PT hour one (1) winner will be selected at random from all the Qualifiers received during the week 4/27/2009-5/1/2009 to win Week #3 Trip.
- f. The odds of winning will depend on the number and order of calls received.
- g. You must listen to be a Qualifier, however, each WEEKLY WINNER DOES NOT NEED TO LISTEN TO WIN.
- h. Winners will be contacted via telephone at 5pm on each Friday during the Contest. **In the event the winner cannot be contacted at that time, KXTE will attempt to contact the winner again on the following Monday approximately 11:00am PT. If the winner does not respond within 24 hours of the second attempt, an alternate winner will be selected by random drawing from all remaining Qualifiers and will be notified by phone.**

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winners. Winners will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by the Station in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize.
- b. By participating in the Contest, the winner or winners agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this Contest without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize or prize certificate, the Station in its sole discretion may require Contest winners (and their travel companions, if any) to sign a liability release, agreeing to hold the Station, its corporate licensee, its parent, subsidiary and affiliated corporations, and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the Contest.

- d. The Station reserves the right to make changes in the rules of the Contest, including the substitution of a prize or equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Station, any competition or prize-related event is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but not the obligation, to cancel or modify the Contest and shall not be required to award a substitute prize.
- e. Failure to comply with the Contest rules may result in a contestant's disqualification solely at the discretion of the Station.
- f. The Station is not responsible for typographical or other errors in the printing, the offering or the administration of the Contest, or in the announcement of a prize.
